Evergreen placed a deadline of April 5, 2019 at 2:00 p.m. The RFP stated Evergreen Memorial Cemetery is accepting bids for Milling & Paving of Roads.

Saw cut and remove headers at each resurface area. Milling: 1.5" depth on designated surfaces. Paving: 1.5" of asphalt surface on designated surfaces. New parking area in front of cemetery office: Ground prep work will be done by cemetery personal. Sealing of cracks in cemetery roads to be determined by Cemetery Manager. Clean up of all left-over material.

Subject: Analysis of Request for Proposals for Tree removal and pruning

Several trees in the cemetery have become infested with insects or are diseased and needs to be removed or pruned. A Request for Proposal (RFP) for tree removal and pruning was advertised on March 5, 2019. Evergreen placed a deadline of April 5, 2019 at 2:00 p.m. The RFP stated that the Contractor shall remove trees deemed necessary for removal by Cemetery Manager. Clean up of all debris and stump removal by contractor. All trees shall be limbed out using appropriate rigging techniques to protect public safety and prevent unnecessary damage to surrounding turf, trees, shrubs, landscape plantings and tombstones. The Contractor shall prune trees designated by Cemetery Manager. Trees designated for pruning will be pruned of all dead, diseased, dying, doubled or broken limbs greater than two (>2) inches in diameter. In the case of ornamental/specimen trees, shaping for aesthetics may be requested.

Five (5) proposals were received and evaluated. Due to the importance of accuracy, timeliness, technical knowledge and experience with Cemetery, the lowest cost was not the only factor in the selection process.
