Subject: Analysis of Request for Proposals for Milling and Paving Roads

Several roads at the cemetery have damage or have high curbs and need to be milled down. A Request for Proposal (RFP) for Milling & Paving of cemetery roads was advertised on March 15, 2021. Evergreen placed a deadline of April 9, 2021 at 2:00 p.m. The RFP stated Evergreen Memorial Cemetery is accepting bids for Milling & Paving of Roads.

Saw cut and remove headers at each resurface area. Milling: 1.5" depth on designated surfaces. Paving: 1.5" of asphalt surface on designated surfaces. Clean up of all left-over material.

Four (4) proposals were received and evaluated. The lowest bid was accepted.

Each company submitted a proposal – in a sealed envelope which was opened on April 12, 2021 at 6:02 P.M. Witnesses present during the bid opening were:
