She said that ever since the first tent was allowed to stay many others from the church parking lot have moved over. Trustee Gibson said the main concern is safety for staff and customers. The township Supervisor said there is going to be a work session on Friday July 12, 2024, at 7:30 AM in the cemetery office so that the Mayor and City Manager can put eyes on the situation.
